Since October of 1997, Humboldt Transit Authority has had a Life Insurance/Accidental Death And Dismemberment plan of \$5,000 for all employees with Standard Insurance Company. From the recent labor negotiations AFSCME and HTA agreed to increase the rate to \$10,000 for all employees. The cost to HTA is \$1,200 per year with an effective date of February 1, 2013.

I understand that any increase in Insurance for a Member who is not Actively At Work all day on the Member's last regular work day before the scheduled effective date of the amendment will be deferred until the first day after the Member completes one full day of Active Work.

I request that the amendment, if approved and issued by The Standard, become effective by its terms without any further acceptance by the Employer, and that a copy of this Request for Group Insurance Amendment form be attached to and made a part of the amendment.

b. Northern California Consortium

The Regional Sales Manager from Gillig notified staff that the Central Contra Costa Transit Authority is accepting requests to become member of the Northern California Consortium

to purchase buses. Becoming a member does not obligate HTA to purchase vehicles off of the Contract.

Motion by Councilmember Fulkerson, second by Councilmember Winkler to direct General Manager Greg Pratt to send a letter to Central Contra Costa Transit Authority requesting to be a member of the Northern California Consortium.

c. Lease Agreement with Humboldt Redwood Company

Humboldt Transit Authority's lease of space in Humboldt Redwood Company's telecommunications vault and on the tower on Mt. Peirce expires 12/31/2012 and is up for renewal.

Motion by Councilmember Winkler, second by Councilmember Fulkerson to authorize General Manager Greg Pratt to sign the agreement between Humboldt Transit Authority and Humboldt Redwood Company at the cost of the contract and to also negotiate better price.

d. Conference with Labor Negotiators

Public Comment

Harriet Lawlor, AFSCME's Business Agent announced that AFSCME and HTA have reached an agreement and gave the board a summary of the proposed agreements.

At 9:36 a.m. the board went into closed session pursuant to Government Code Section 54957.6. Agency designated representative: Greg Pratt. Employee Organization: American Federation of State, County and Municipal Employees Local 1684, AFL-CIO.

The board resumed open session at 10:22 a.m. Vice Chairperson Lovelace announced that there was nothing to report.

e. <u>Memorandum of Understanding between Humboldt Transit Authority (HTA) and the American Federation of State, County and Municipal Employees (AFSCME)</u>

The employee's contract between HTA and the Union expired on June 30, 2012. Staff and AFSCME have agreed upon the language of a successor Memorandum of Understanding and an agreement between AFSCME and HTA regarding issues not covered by successor MOU, which would implement the Tentative Agreement. A new proposal to be discussed at the Government Code Section 54957.6 closed session.

Humboldt Transit Authority's legal Counsel, Nancy Diamond announced that there is a new proposal. Presently HTA pays full contribution towards employee's retirement. Employees will receive a 7% increase and will have the employee's retirement contribution deducted from their payroll check. Also in the proposal is a side agreement. Harriet Lawlor agreed and indicated there were no disputes.

Motion by Supervisor Sundberg, second by Councilmember Fulkerson to adopt the new Memorandum of Understanding (MOU) and Agreement between AFSCME and Humboldt Transit Authority with the two (2) noted side agreements.
