CALL TO ORDER

Chairperson Atkins called the meeting to order at 9:00 a.m.

INTRODUCTIONS & RECOGNITIONS

The board members introduced themselves. Others in attendance were: Harriet Lawlor, AFSCME Business Agent; Jeff Willis, Dave Carter and Brian Connors, HTA Coach Operators; Sherry Dunlap and Dan Gerber, HTA Coach Operators and members of the AFSCME negotiations team; Neleen Fregoso, Fortuna resident; Dave Carstenson, Caltrans Regional Planning; Marcella Clem, HCAOG.

MINUTES

Neleen Fregoso requested that Action Item f. Bus Service from Eureka to San Francisco Airport be revised to read: "At the September meeting, Councilmember Fulkerson requested that staff put bus service between Eureka and San Francisco Airport on the agenda to discuss what options are available. General Manager Pratt advised the board that he contracted with Neleen Fregoso to conduct a study as to this subject. The board suggested keeping this item on the agenda for further discussion and the possibility of creating a sub-committee." The reference to a relation between her study and the information found on October's agenda page 14 was stricken from the record.

Motion by Councilmember Fulkerson, second by Councilman Glaser to approve the revision and to adopt the minutes from the October 17, 2012 board meeting as revised.

CITIZENS COMMUNICATIONS

Prior to opening up the floor to Citizens Communications, Chairperson Atkins announced that item F on the November 28, 2012 agenda, "Memorandum of Understanding Between Humboldt Transit Authority (HTA) and the American Federation of State, County and Municipal Employees (AFSCME) and Agreement Between HTA and AFSCME Regarding Issues not Covered by the Successor MOU for November 28, 2012 — June 30, 2015." was being removed from the agenda inasmuch as the board was not ready to address it at that time.

Citizens Communications: Harriett Lawlor, Business Agent for AFSCME, address the board. She said that since the negotiating teams had reached agreement HTA was presenting the employees with an additional requirement to include an issue that was outside the scope of the contract. She reminded the board that the employees had already agreed to waive their right to back payment for certain infringements to their work schedules in order to come to an agreement over the contract. She also reminded them that to sign off their rights relating to said infringements was beyond the union's authority to do and that the employees could not and would not sign a waiver of those rights.

Some discussion took place regarding the history of the Southern Humboldt Local Service for the benefit of newly appointed board members. Currently the service needs about 3 to 4 additional daily riders in order to meet it's required performance goals.

The Central Contra Costa Transit Authority (CCCTA) is putting together a Request for Proposal (RFP) and will be the lead agency for a Northern California Consortium bus procurement contract. If HTA would like to be a named consortium member on the RFP, a letter (see attached) would need to be sent to CCCTA. By doing so, HTA can reserve options for our agency to purchase buses for the 5 year period of the contract. Requesting to be a consortium member does not obligate HTA to purchase any vehicles off the contract. It only reserves options for HTA should we elect to do so. Being a consortium member streamlines HTA's bus purchase process by eliminating the need to prepare our own "piggyback" or bus procurement RFP, which can be a very time consuming process. The consortium will have an extensive price list of bus features that include selections for 30', 35' and 40' buses. Also, there will be choices for diesel, diesel/electric hybrid and CNG propulsion systems.

To Whom It May Concern:

Humboldt Transit Authority's (HTA) lease of space in Humboldt Redwood Company's (HRC) telecommunications vault and on the tower located on Mt. Pierce expires 12/31/2012, and HRC is extending an offer to enter into a new lease agreement beginning January 1, 2013. The terms of the new lease are a result of market driven conditions and terms derived from a competitive market and comparable equipment and services provided.

HTA previously had a lease with The Pacific Lumber Company for the same equipment and services as now that began December 1, 1996 for a term of five years for a rent of \$50.00 per month. At the end of the original term, an optional extension was available to extend the term an additional five years through 2006, during which term the rent would be adjusted annually based on increases in the Consumer Price Index. The Lease expired 12/1/2006, but was allowed to continue on a "month to month" basis. HRC assumed ownership of the company after bankruptcy in 2008. HRC notified HTA of the need to enter into a new lease agreement in 2011 and HTA agreed to a new lease with new terms beginning 7/1/2011. The new terms included an increase in rent to \$1,700.04 per year, payable in monthly installments of \$141.67, but due to an oversight in both accounting organizations the rent payments were never implemented. The 2013 lease annual rent of \$3,000.00 is based on current market values for telecommunications space and is comparable to that paid by other leaseholders in a similar use, service and market category.
